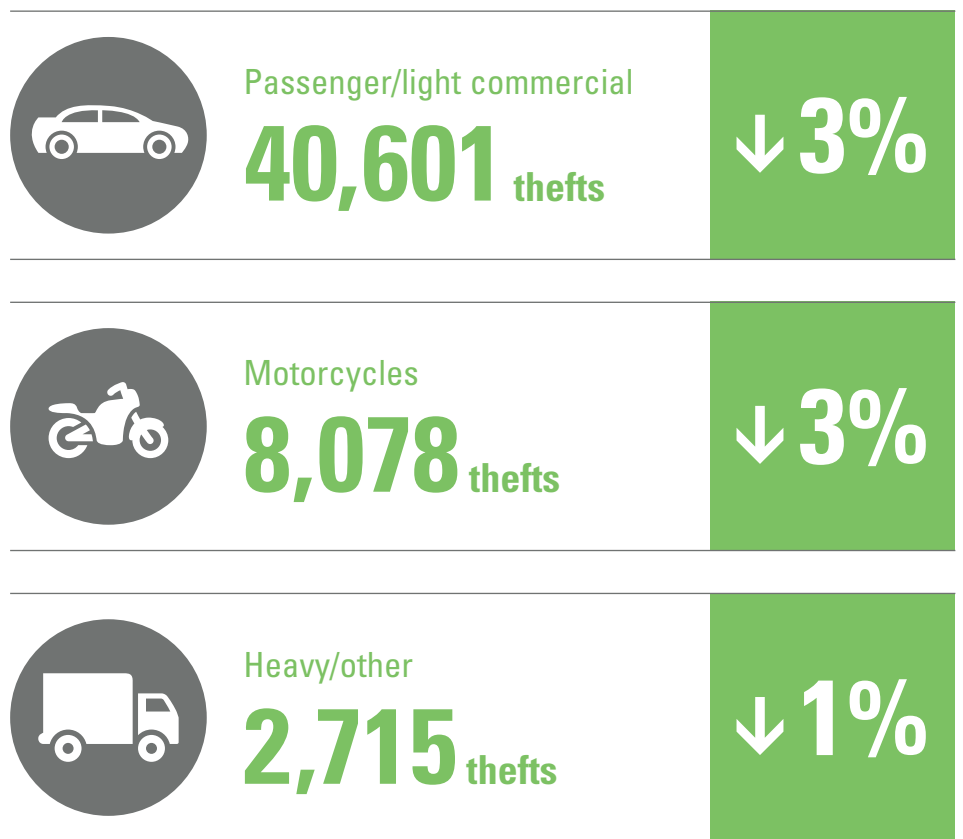

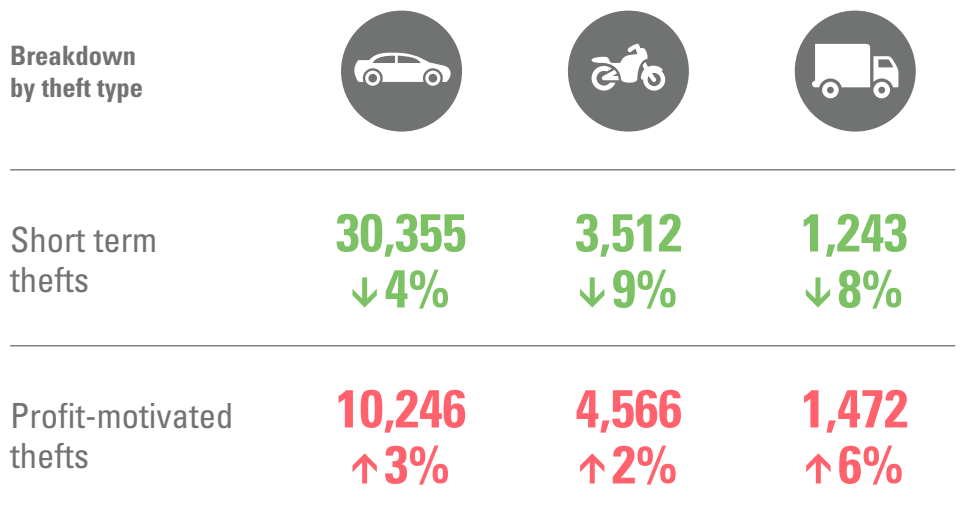

### Total vehicle thefts

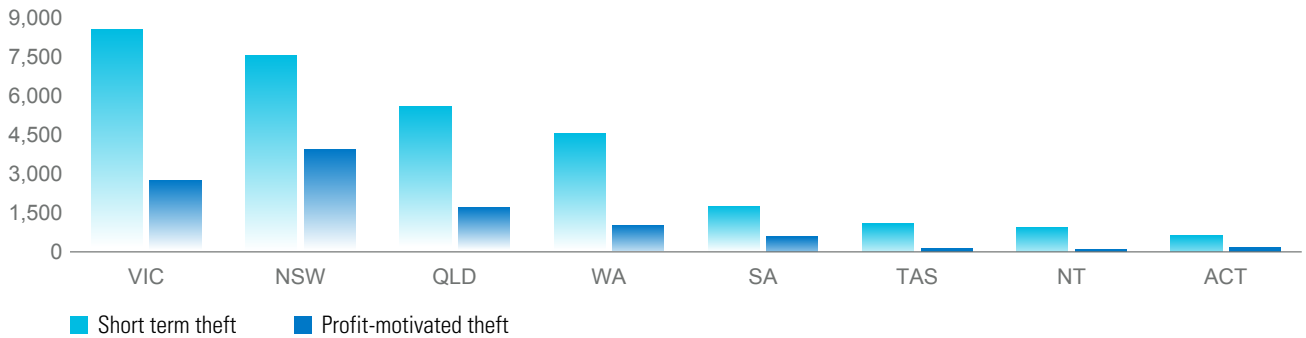


### Breakdown by theft type



# State and territory breakdown – PLC theft

**Number of vehicle thefts 2014/15**



Victoria has now overtaken NSW for the highest number of short term PLC thefts in a 12 month period. NSW maintained the highest volume of profit-motivated thefts.

**Percentage change from 2013/14**



QLD experienced the largest reduction of 1,104 thefts in the period.\*

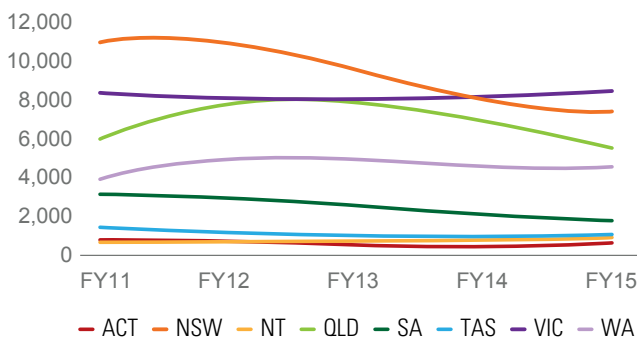
**Theft rate per 1,000 registrations**



Of the larger jurisdictions, WA had the highest short term theft rate of 2.29 per 1,000 registrations. NSW maintained the highest profit-motivated theft rate of 0.81.\*

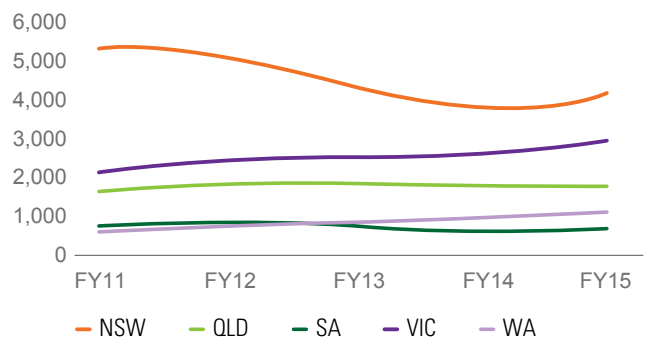

**Short term theft (five year trend)**



Short term PLC theft in NSW has fallen by 31 per cent over the past five years. Thefts have increased over the same period in VIC, WA and the NT.

**Profit-motivated theft (five year trend)**



Profit-motivated theft in NSW has followed a similar trend, declining 26 per cent over the five year period. Thefts have been steadily increasing in VIC and WA. Profit-motivated theft in the ACT, TAS and the NT has remained relatively steady over the past five years.\*
